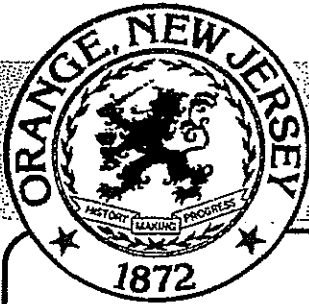

## SMOKE DETECTOR CERTIFICATES

### Residential One and Two Family Households

#### 1. Smoke Detectors (Effective: January 1, 2019)

- The household shall have a detector on each level of the structure. (*Living area*)
- The household shall also have a detector outside each separate sleeping area.
- The detectors shall be located on or near the ceiling.
- Ten year sealed battery-powered single stations smoke detectors shall be installed and shall be listed in accordance with ANS / UL 217. **Also, proof of purchase is required the day of inspection.** Example: detector box or receipt

#### 2. Carbon Monoxide Detectors

- Detectors are required on each floor which is used for sleeping
- Placed in close proximity of the bedroom areas of the dwelling.

#### 3. Fire Extinguishers

- ABC type of extinguisher is required
- Minimum size 2a:10b: C, rated for residential usage.
- A 10 lb. Extinguisher is the maximum size allowed by the fire code.
- The extinguisher shall be mounted within 10 ft. of the kitchen area.
- The extinguisher shall not be mounted in a closet, cabinet. *The extinguisher visibility shall be in an open area and easily accessible.*
